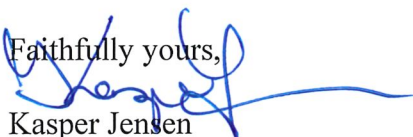
Chief Executive Officer and Chief Operating Officer being the top managers of Sodru S.A. (hereinafter referred to as „Top Management“) which is a holding/ parental company of Intergrain S.A. (Luxembourg), European Commodity Company S.A. (Luxembourg), Sodru Trading S.A. (Switzerland), hereinafter referred to as „Companies“, hereby declare that Companies meet and comply with the below requirements while performing its main commercial / business activities:

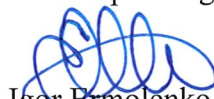
Proterra Standard	Standard to promote sustainability in the food and feed supply chain and segregated non-GMO materials.
Europe Soya	Europe Soya quality programme has been established to promote and propagate the cultivation, processing and marketing of sustainable, non-GM, origin-controlled quality soya from Europe. The aim is to develop and guarantee a sustainable non-GM protein supply in and from Europe.
VLOG 25.01	Production and certification standard developed by VLOG safeguarding the criteria of the EC Genetic Engineering Implementation Act.
Food Chain NON GMO Standard	Management system used to ensure traceability and preservation of identity of non-GMO products.
SODRU SUSTAINABLE SOY	Standard for responsible soy production, ensuring legal compliance, responsible labor conditions, environmental protection, good agricultural practices, and community relations
GMP+ Feed Safety Assurance	System for management of safety and quality of feed products and related services in trade, storage and transshipment.

Bearing in mind that feed is a part of the food chain Top Management is aware of its responsibility for feed safety. By declaring the above Top Management will:

- a) Make the organization aware of the importance of feed safety and of compliance with above the requirements of above mentioned standards, the obligations of the feed legislation and the requirements of the customer.
- b) Record specific policy objectives with respect to feed safety in writing in a statement of policy.
- c) Demonstrate its responsibility and involvement in the development and introduction of the feed safety management system to achieve safe feed.
- d) Put together a HACCP team.
- e) Ensure that resources and manpower are available. Management must itself determine what resources are necessary for the guaranteeing of safe feed and ensure that these resources are also available. There must at least be compliance with the requirements of this standard.
- f) Assess at least once per 12 months whether the feed safety management system is still suitable and effective.
